

## CARRIAGE OF FIREARMS AND/OR AMMUNITION TO/FROM DUBAI OR LONDON ON QANTAS FLIGHTS

Passengers travelling to or from Dubai or London on QF01/02 and QF09/10 are required to send the below documentation to Qantas Dangerous Goods.

The documentation will be held on file and, in the unlikely event of a disruption via Dubai; an approval will be sourced by Qantas ground personnel.

Each passenger travelling on a Qantas flight must complete the 'Firearms/Weapons & Ammunition Declaration' (attached below).

The Declaration form must be submitted to [dq@qantas.com.au](mailto:dq@qantas.com.au) together with the following documentation:

- **clear** scan of passport;
- **clear** scan of firearms license;
- export/import permit; and
- invitation letter (if any).

Once documentation has been received by Qantas Dangerous Goods an acknowledgement email will be forwarded.

**NOTE:** *Passengers carrying ammunition on any Qantas Group flight are still required to obtain a Qantas Dangerous Goods Operator Approval ([dq@qantas.com.au](mailto:dq@qantas.com.au)).*
