

CPAPs (CONTINUOUS POSITIVE AIRWAY PRESSURE)

Specific requirements apply to the carriage of battery operated CPAP equipment. When travelling on Qantas Airways, QantasLink, Jetconnect, The Jetstar Group, Cobham or Network Aviation the following applies:

- lithium batteries, battery packs and spare batteries **under 101Wh** – do not require a dangerous goods operator (airline) approval;
- lithium batteries, battery packs and spare batteries **exceeding 101Wh** – requires a dangerous goods operator (airline) approval and spare batteries are limited to two per passenger (contact dg@qantas.com.au for more information)
- all spare batteries and battery packs must be carried in carry-on baggage only

Prior to travel, passengers must contact Qantas Special Handling (specialhandling@qantas.com.au), to obtain a medical clearance and if applicable, request the use of aircraft power.
